# Statement regarding DC question number 2010032501, "Has a Bankruptcy Credit Event occurred with respect to Ambac Assurance Corporation?"

The ISDA Credit Derivatives Determinations Committee for the Americas (the "DC") has resolved to publish the following statement regarding DC question number 2010032501, "Has a Bankruptcy Credit Event occurred with respect to Ambac Assurance Corporation?".

Any capitalized term used but not defined in this statement shall have the meaning given to such term in the 2003 ISDA Credit Derivatives Definitions, as amended by the 2009 ISDA Credit Derivatives Determinations Committees, Auction Settlement and Restructuring Supplement to the 2003 ISDA Credit Derivatives Definitions published by the International Swaps and Derivatives Association, Inc. ("ISDA") on July 14, 2009, or the Credit Derivatives Determinations Committee Rules published by ISDA on December 18, 2009 (the "DC Rules")<sup>1</sup>.

On Friday May 21, 2010, ISDA published the Initial List of Deliverable Obligations for the auction to be held for purposes of settling Credit Derivatives Transactions referencing Ambac Assurance Corporation (the "Initial List"). For the purposes of publishing the Initial List, the DC Resolved, for each obligation that was submitted (and not withdrawn) and for which full documentation was provided, whether such obligation qualifies as a Deliverable Obligation or not. There are two exceptions to this: CUSIPS 63544DAK8 and 63544EAJ9, for which full documentation has been received but the DC did not Resolve whether such obligations qualify as Deliverable Obligations or not. These two obligations therefore do NOT appear on the Initial List. Under Section 3.3(c) of the DC Rules, market participants now have an opportunity to submit any obligations (including, for the avoidance of doubt, the two obligations noted above or any obligations that the DC has Resolved do not qualify as Deliverable Obligations) for inclusion on the Supplemental List of Deliverable Obligations (the "Supplemental List"),

Market participants who wish to submit obligations that do NOT appear on the Initial List for inclusion on the Supplemental List must submit such obligations, together with any missing documentation, by 5pm New York time on Monday, May 24, 2010 in accordance with Section 3.3(c) of the DC Rules.

Please note that a party who submits an obligation for inclusion on the Supplemental List will be subject to bearing the legal costs of reviewing the relevant documentation if such obligation is successfully challenged, as described further in Sections 3.3(c) and 3.3(e) of the DC Rules.
