For the avoidance of doubt, transferees under a Representative Auction Settled Transaction will not become obliged to adhere to the DISH DBS Corporation Lock-Up Agreement by virtue of their participation in the DISH DBS Corporation Auction. “**DISH DBS Corporation Lock-Up Agreement**” means that certain Restructuring Support Agreement (as amended, supplemented, or amended and restated from time to time and including as all exhibits and schedules attached thereto, the **RSA**), dated as of March 19, 2026, among *inter alios* DISH DBS Corporation and certain of its creditors, or any other agreement in substantially the same form as the RSA entered into between DISH DBS Corporation and any of its creditors from time to time.
